# List of contributors

**Matthew Adams** is Assistant Professor in philosophy at the University of Indiana, Bloomington. His research interests are in political philosophy, ethical theory, and applied ethics. He has published several articles in these areas, as well as co-editing *Methods in Bioethics: The Way We Reason Now* (2017).

**Christian Baatz** is Professor of Climate Ethics, Sustainability and Global Justice at Kiel University, where he is leading a research project on the just distribution of climate change adaptation finance. His current work also focuses on the justification and application of human rights norms.

**Katharina Bauer** is Assistant Professor of practical philosophy at Erasmus School of Philosophy. Her areas of specialisation are moral philosophy, self-optimization and enhancement, theories of practical necessity, and theories of personal identity and character.

**Aveek Bhattacharya** is Chief Economist at the Social Market Foundation, a non-partisan think tank based in London. He holds an MPhil in Political Theory from the University of Oxford and a PhD in Social Policy from the London School of Economics and Political Science. He is one of the editors of *Justice Everywhere*, a blog about philosophy in public affairs.

**Paul Billingham** is Associate Professor of Political Theory and a Fellow of Magdalen College at the University of Oxford. Most of his research focuses on debates within political liberalism and concerning the place of religion in public life.

**Nicolás Brando** is Newton International Fellow (British Academy) at the Centre for Children's Rights at Queen's University Belfast. His research focuses on justice, education and children's rights. He is co-editor of the volume, *Philosophy and Child Poverty: Reflections on the Ethics and Politics of Poor Children and their Families* (2019).

**Kimberley Brownlee** is Professor of Philosophy at the University of British Columbia. Her current work focuses on the ethics of sociability, social rights, human rights, and freedom of association. Most recently, she has been leading a project entitled 'Investigating the Ethics and Politics of Sociability', which has produced – among other things – a monograph called *Being Sure of Each Other* (2020).

**Rowan Cruft** is Professor of Philosophy at the University of Stirling. His research examines the nature and justification of rights and duties, and their role in shaping a democratic public sphere. Most recently, he has published a monograph entitled *Human Rights, Ownership, and the Individual* (2019). His research is guided by the aim of demonstrating how philosophical positions bear on the justification of public policies and law and, to this end, he has participated in policy development and public inquiries, including as an invited witness at the Leveson Inquiry and as co-author of a submission to the Commission on a Bill of Rights for the UK.

**Avner de-Shalit** is a political philosopher and Max Kampelman Chair of democracy and human rights at the Hebrew University of Jerusalem. His research and teaching interests lie in equality, democracy and human rights, environmental politics and urban politics. His current research focuses on political theory and cities, about which he has published two books: *The Spirit of Cities: Why the Identity of a City Matters in a Global Age* (with Daniel Bell, 2013) and *Cities and Immigration: Political and Moral Dilemmas in the New Era of Immigration* (2018).

**Katarina Pitasse Fragoso** is a postdoctoral research fellow in the Political Science department at São Paulo University, where her research is attached to the Center for Metropolitan Studies. Her work focuses on issues of relational inequalities, poverty and public policy.

**Anca Gheaus** is Assistant Professor in Political Theory at the Central European University in Vienna. Her research centres on justice and the normative significance of personal relationships. She is the co-editor of the *Routledge Handbook of the Philosophy of Childhood and Children* (with Gideon Calder and Jurgen De Wispelaere, 2018) and is currently writing a monograph on child-centred childrearing.

**Julia Hermann** is Assistant Professor in Philosophy and Ethics of Technology at the University of Twente. Her current research is embedded in the 10-year research programme “The Ethics of Socially Disruptive Technologies”, funded by the Dutch Organisation for Scientific Research (NWO). She is the author of the book *On Moral Certainty, Justification and Practice: A Wittgensteinian Perspective* (2015).

**Lisa Herzog** is Associate Professor and Rosalind-Franklin-Fellow in the Faculty of Philosophy and the Center for Philosophy, Politics and Economics at the University of Groningen. Her research lies at the intersection of political philosophy and economic thought. She is the author of *Inventing the Market* (2013) and *Reclaiming the System: Moral Responsibility, Divided Labour, and the Role of Organizations in Society* (2018).

**Jeffrey Howard** is Associate Professor of Political Theory at University College London. He works on topics in contemporary political and legal philosophy, focusing on freedom of speech, criminal punishment, and democracy.

**Viktor Ivanković** is a research assistant at the Institute of Philosophy in Zagreb, Croatia. He holds a PhD in Political Theory from Central European University. His current research focuses on the ethics of nudging, namely, the institutional requirements for nudge permissibility. His other interests are in distributive justice and bioethics.

**David Jenkins** is Lecturer in Political Theory at the University of Otago. His current work focuses on sociality within urban experiences, the concept of partisanship (with an emphasis on the Communist Party India (Marxist) in Kerala) and homelessness and housing rights. He is co-editor, together with Kimberley Brownlee and Adam Neal, of *Being Social: The Philosophy of Social Human Rights* (2021).

**Rebecca Lowe** is a doctoral researcher at King's College London, and research director at an investment company. Her current research is on Lockean justifications for private property. She is the former (and inaugural) director of FREER, a small think tank promoting economically and socially liberal ideas housed at the Institute of Economic Affairs, where she was also a research fellow.

**Fay Niker** is Lecturer in Philosophy at the University of Stirling. Her main research and teaching interests lie in social and political philosophy and practical ethics. Within this, her current research focuses on the ethics of influence broadly understood, including topics such as autonomy, paternalism, nudging, and trust. She also co-edits a collaborative blog about philosophy in public affairs, *Justice Everywhere*.

**Onora O'Neill** is Emeritus Honorary Professor at the University of Cambridge and a cross-bench Member of the House of Lords. Baroness O'Neill has written widely on political philosophy and ethics, international justice, and bioethics. In addition to serving as a member of the House of

Lords since 2000, she has also: served as President of the British Academy (2005-2009); chaired the Nuffield Foundation (1998-2010); and chaired the Equality and Human Rights Commission (2012-2016).

**Tom Parr** is Associate Professor in Political Theory at the University of Warwick and a Marie Skłodowska-Curie Individual Fellow at Universitat Pompeu Fabra, Barcelona. He is currently completing a project on ‘Social Justice and the Future of Work’. His first book is *Introducing Political Philosophy: A Policy-Driven Approach* (with Will Abel, Elizabeth Kahn and Andrew Walton, 2021).

**Felix Pinkert** is Assistant Professor of Philosophy and Economics at the University of Vienna, working on contemporary moral, political, and social philosophy. His research is motivated by an interest in ethical puzzles that arise when we can make the world better only by working together, in climate ethics, and in how to justly live together in an ideologically, religiously, and culturally diverse society.

**Diana Popescu** is a teaching fellow at King’s College London. She works on distributive justice, recognition theory, and the relation between the two with respect to recognition struggles, disability rights, minority discrimination and social exclusion.

**Lovro Savić** is a doctoral researcher at the Ethox Centre, Wellcome Centre for Ethics and Humanities, and Green Templeton College, University of Oxford. His research interests include public health ethics, bioethics, and philosophy of medicine and psychiatry.

**Marc Stears** is the Director of the Sydney Policy Lab at the University of Sydney. Before this, he was Professor of Political Theory at the University of Oxford and Chief Executive of the New Economics Foundation. He has also been Chief Speechwriter to the UK Labour Party, a co-author

of the party's 2015 election manifesto and a member of the Party's general election steering committee (2012-2015). In his academic work, Professor Stears is an expert in democratic theory and the history of ideologies and social movements. His most recent book is *Out of the Ordinary: How Everyday Life Inspired a Nation and How It Can Again* (2020).

**Adam Swift** is Professor of Political Theory at University College London. He works on a wide range of issues in political theory, and with a wide range of collaborators. In recent years he has come to specialize in debates around equality of opportunity, education and the family. His most recent books are *Educational Goods: Values, Evidence and Decision Making* (with Harry Brighouse, Helen F. Ladd and Susanna Loeb, 2018) and *Family Values: The Ethics of Parent-Child Relationships* (with Harry Brighouse, 2014).

**Sara Van Goozen** is Associate Lecturer in Political Philosophy at the University of York. Her research focuses on topics in contemporary just war theory and the ethics of killing, but she also works on issues relating to migration, animals, and political obligations.

**Alexandru Volacu** is Associate Professor in the Faculty of Business and Administration at the University of Bucharest, and Director of the Bucharest Center for Political Theory. He is currently the director of a national research grant titled "Electoral rights: a relational approach", and is a member of the REDEM Horizon 2020 project consortium. His research focuses on the ethics of voting, justice, and the ideal/non-ideal theory debate. His most recent book is *Do We Have a Duty to Vote [Avem datoria de a vota?]* (2019), published in Romanian.

**Katy Wells** is Assistant Professor in Political Theory at the University of Warwick. Her research focusses on property and justice and, specifically, on the topics of housing and renting. She is currently writing a book about renting.

**Jonathan Wolff** is the Alfred Landecker Professor of Values and Public Policy at the Blavatnik School of Government at the University of Oxford. He is the author of several books in ethics and political philosophy, including *An Introduction to Political Philosophy* (1996, third edition 2016), *Disadvantage* (with Avner de-Shalit, 2007), *Ethics and Public Policy: A Philosophical Inquiry* (2011, second edition 2019), *The Human Right to Health* (2012) and *An Introduction to Moral Philosophy* (2018, second edition 2020). He is currently developing a new research programme on revitalising democracy and civil society, in accordance with the aims of the Alfred Landecker Professorship.

**David Yarrow** is Lecturer in International Political Economy at the University of Edinburgh. His research focuses on how economic ideas and expertise are used in public administration and democratic discourse. Specifically, he explores how these economic ideas and expertise serve to naturalise contestable assumptions about human nature, work, money, ethics and the environment, and the implications of this for contemporary economic policy debates.
