## YOUR VIEWS

### On the need for legislation

- Q1** Do you agree that legislation to embed the UNCRC within the Scottish Government's decision-making and day-to-day business is necessary and appropriate?

Any proposal designed to ensure better compliance with the UN Convention on the Rights of the Child is to be welcomed. However, this proposal does not go far enough. A real commitment to children's rights requires ***incorporation***, by statute, of the Convention into Scots law.

Given the competence of the Scottish government in respect of reserved matters, an alternative approach would be to pass a statute incorporating all of the Convention's provisions except those dealing with reserved matters (e.g. nationality).

An additional benefit of incorporation and, to a lesser extent, embedding, might be to heighten awareness of the Convention amongst the general public, including children. It will be remembered that article 42 requires states parties to "make the principles and provisions of the Convention widely known .... to adults and children alike." Neither the Scottish nor United Kingdom government has done nearly enough, in this respect, to date.

It might be argued that embedding is better than doing nothing at all, but it would amount to little more than a cosmetic exercise.

### **Proposal 1**

**Q2** Do you agree that "due regard" is the appropriate level of regard for the duty on the Scottish Ministers? If not, why not?

Arguably, this requires less of the Scottish Ministers than is required of United Kingdom government ministers (and, derivatively, Scottish Minister) under international law in respect of a treaty ratified by the United Kingdom.

The term "due regard" is so vague as to be virtually meaningless, albeit, it is found in other legislation. The obligation placed on the Scottish Ministers should be to "ensure compliance with the provisions of the United Nations Convention on the Rights of the Child".

Doubtless, issues will arise where there is disagreement over precisely what is required for compliance, but the ensuing debate can only serve to further understanding of the Convention and what it requires.

**Q3** Do you agree that the duty should apply to all the functions of the Scottish Ministers? If not, why not?
